Capital Roots' Educator prepares and presents classes and workshops related to gardening, healthy meal preparation, food preservation and wellness to the general public and in collaboration with a wide range of community partners including health care and senior service providers, social service agencies, nonprofit organizations and schools. The Educator implements a 5-week nutrition education program for young children (Pre-K through 2nd grade) called the 'Taste Good Series' which introduces children to new fruits and vegetables through fun and engaging activities and tastings.

This position is a non-exempt, full-time position (40 hours per week) with starting salary of \$28,080 per year. We offer comprehensive health care coverage upon hire with fully covered premiums for medical insurance and 75% coverage for dental insurance. We offer plans with low-cost co-pays and deductibles – a benefit of ~\$7,000 per year. Generous time off every year that includes paid holidays, vacation, sick and personal days. Employer funded pension plan - company contributions begin after 2 years of employment.
